Overall migration: 2 hours at 70°C, used simulants A, B, 4 hours at 60°C simulant 95% ethanol and 0,5 hours at 40°C simulant iso-octane Specific migration melamine: 2 hours at 70°C, used simulant B Specific migration formaldehyde: 2 hours at 70°C, used simulant B

 Ratio of food contact surface area to volume used to determine the compliance of the article: Volume ratio = 6 dm²/ kg
